2.0 Meeting Minutes:

Meeting called to order by Greg Hiller at 7:00 PM.

2.1 Reading and Approval of Minutes:

Don Davis read the minutes for the February meeting. A correction was made on item #3.4 “the Saturday Hunter Ed. course is from 8:00 AM – noon”. Approved.

2.2 Reports of Officers, Boards and Standing Committees:

Jeff Kunzer read the Treasurer’s report for February. Approved.

3.0 New Business:

3.2 Wil Harding asked if he has the range reserved for his upcoming class. The range is reserved.

3.3 Don Smith shared information from the Federation regarding a youth fishing derby. Fishing poles were bought from B&E prior to its closing. Some will be sold and put in libraries and others will be used as prizes for the fishing derby. Don commented that the Federation is doing a lot of good things with our youth.

3.4 Jeff asked if we should give a donation to the Federation. All agreed. A motion was made for making a one-time donation to the Federation for \$300.00. Approved.

3.5 Greg asked if there was anything we could do to draw more shooters to our range. There was some discussion and most agreed it is a good course and no changes were recommended.

3.6 Greg expressed concern regarding the number of people helping to maintain the course (fill machines, change batteries, etc.) Greg pointed out that if we can't get volunteers to help we may have to hire it out and that would raise range costs and fees.

3.7 A question was raised regarding the 5 year handgun renewal process. There was discussion and the process was clarified.

3.8 Don Smith reminded us that SCOPE has tote bags for sale as a fund raiser for \$5.00 each. He also passed out some literature on gun legislation. A good deal of discussion followed.
