**Meeting Minutes for Tuesday June 6th, 2023**

**Call to Order**

Vice President Jim Sweet called the meeting to order at 7:00 PM immediately following the Pledge of Allegiance to the Flag.

**Officers Reports**

- Minutes for the May 2nd, 2023 meeting were read and approved.
- Club Treasurer Jeff Kunzer gave his report for May. His report was approved.
- Jeff Kunzer reported there were 539 paid members as of May 31, 2023.

**Old Business:**

- The bucket truck has been put into use cutting down ash borer infected trees on the Sporting Clays course. It works well for the intended job and there is much more to do.
- Our new supply of clay targets has been delivered, unloaded and stored in the barn. About a 35% increase in cost compared to the last purchase so a cost increase in shooting will be needed. One cost increase already implemented is buying shooting certificates. Instead of a book of 12 tickets with each ticket worth \$10.00 for a cost of \$100.00, it will now contain 11 tickets for \$100.00. The cost to shoot with additional extra targets may be changed.
- The Civilian Marksmanship Program (CMP) ran by Don Rimai this past Saturday, June 3<sup>rd</sup> went well.
- The Wayne County Federation of Sportsman's Clubs annual banquet held on Saturday May 13<sup>th</sup> at the Red Creek Conservation Club went well. WCSC is looking for a member to represent us at their monthly meetings held on the 3<sup>rd</sup> Tuesday of the month at the Red Creek Conservation Club.

- The club Top Shot Contest will be held again this year on Saturday June 10<sup>th</sup> and will be the same as last year. It will consist of 25 clay targets shot on the Sporting Clays course; 10 rifle shots at 25 yards and 10 pistol/revolver shots at 7 yards worth up to 100 points. Shoot from 10:00 AM to 2:00 PM. Tim Montondo will manage this event and have score cards available. Cost will be \$20.00 with \$10.00 going to the club and \$10.00 going to the Williamson Ambulance Corp.
